#### Nomination of officers from Local Constitution

#### 5.2 ELIGIBILITY

No person shall be eligible to make nominations, be nominated or vote unless their name appears on the Dues Check-Off printout supplied by the national union sixty days prior to the close of nominations, or they submit a signed Authorization for Dues Withholding (PS Form 1187) fifteen days prior to the close of nominations.

#### **Constitutional Amendments**

#### 8.1 AMENDMENTS

#### A. ELIGIBILITY

Resolutions to amend this Constitution can be proposed by any Full Member (Article 2.2) or Retired Full Member (Article 2.3) of this Local provided that either their name appears on the Dues Check-Off printout supplied by the national union sixty days prior to the date of September regular meeting of the General Membership, or they submit a signed Authorization for Dues Withholding (PS Form 1187) fifteen days prior to the September regular meeting of the General Membership.

#### **B. RESOLUTIONS:**

Proposed resolutions to amend this constitution shall be submitted in writing, clearly specifying all language to be added or deleted, and must be signed by the member proposing the resolution. The proposed resolution must be signed by at least one eligible member, and does not require a second member's signature.

#### C. SUBMISSION & ACCEPTANCE:

Proposed resolutions to amend this constitution shall be submitted to the Secretary either by the adjournment of the September Meeting of the General Membership, or mailed (Postmarked) to the Secretary no later than the date of the September meetings, Any resolutions submitted, and or postmarked after this time shall not be considered, but must be returned to the member(s) with a copy of this article, and be reported to the Membership at the November Meeting
